- An annual registration renewal fee of **\$125 + GST** must be paid by the anniversary date of the registration.
- An MHBA builder member must employ the new home sales agent, Should the employment cease, then the agent's registration shall be suspended. The registration can be re-instated if the agent is employed with an MHBA builder within 12 months. Should the agent change builder employers, then the change of the employer must be reported to the MHBA .
